# Height and weight checks for children in year 6

Every year in England, children in Reception and Year 6 have their height and weight measured at school as part of the National Child Measurement Programme (NCMP). We collect this information to build an understanding of how children are growing. The information is used by local councils and the NHS to support the planning and provision of health services for families. Your child's class will take part in this year's measurement programme.

The measurements will be carried out in school by trained School Nursing staff who will ensure that the measurements are conducted sensitively. Children are measured fully clothed, except for their coats and shoes, in a private space away from other pupils. Children must be physically able to stand to be weighed and measured unaided and any pupils who are unable to do so are not required to participate.

#### Maintaining the well-being of children in the NCMP

The wellbeing of children and families is very important. Measurements are conducted in a sensitive way, in private and away from other children. If you are concerned about your child's growth, weight, body image or eating patterns, seek further support from the School Nursing Service or your GP.

### Results

Individual results are not shared with your child or their school. The weight and height information is shared only with you in the parent/carer feedback letter you will receive by post. It is your choice to share or not share the information with your child. We anticipate that the results letter will be available to you within two months of your child being measured. Please ensure that the school have your accurate postal address as we will use this to send you your feedback letter.

## Withdrawing your child from participating in the NCMP

If you are happy for your child to be measured, you do not need to do anything.

If you do not want your child's height and weight to be measured, or your child has a medical condition that affects their height and weight please complete the attached form and return it to your child's class teacher.

Children will not be made to take part if they do not want to. If your child is absent on the day of measuring, the SNS may revisit the school at a later date to measure your child.

We look forward to your support as we deliver the NCMP over the coming months. If you require any further information on the NCMP or have any concerns about how we will look after your child's personal information, please do not hesitate to contact us.

### **Further information**

#### The information we collect, what it is used for and how it is stored

Your child's height, weight, age, date of measurement, sex and date of birth are collected to calculate your child's weight category (also known as body mass index, or BMI).

Your child's ethnicity and address are collected to monitor differences in child growth and weight between ethnic groups, where children live and their backgrounds.

Your child's name, date of birth and NHS Number are used to link your child's measurements in reception and year 6 to other information from health and education records held by NHS England, the Department of Health and Social Care and the Department for Education, where it is legal to do so.

All this information will be shared with the School Nursing Service to enable them to accurately identify your child and conduct their measurements.

We need your phone number because we may contact you by phone to discuss your child's feedback or offer further support.

The information collected will be held securely by the South Gloucestershire public health and wellbeing division for a minimum of 20 years. We will store your child's information as part of their local child health record on the NHS's child health information database, which a number of medical professionals will have access to for the provision of healthcare and treatment.

We will send all the information collected about your child to NHS England. NHS England is responsible for collecting data and information about health and care so that it can be used to monitor and improve the care provided to people across England.

### Legal basis for processing your child's data

Under Articles 6 and 9 of the UK GDPR, the legal bases we rely on for processing your child's data are that:

we have a legal obligation

- it's necessary to perform a task or function in the public interest or for our official functions and the task or function has a clear basis in law
- it's necessary for the provision of health or social care
- it's necessary for reasons of public interest in the area of public health
- it's necessary for statistical purposes

These legal bases only apply if we take suitable and specific measures to protect your rights, and we only use your information for the purposes we describe in the section above on what we do with your information.

Parental consent is not the legal basis for processing NCMP data.
